Biographical sketch: William Beaton (Bill) (1896-1956) was born to John and Isabella Beaton in East Gwillimbury, York County on August 19, 1896. In 1921, he married Isla Mae Robertson in North Bay, Ontario. Together they had five children: Doreen, Roberta, Lyall, Evelyn and Gwendolyn.

Beaton worked for the Temiskaming and Northern Ontario Railway (TN&O) from 1912 to 1915, until he was hired by the Canadian Pacific Railway (CPR). In 1921 he was transferred to Sudbury as Assistant Chief Clerk. By 1927, he resigned from the railway and remained in Sudbury, where he was self-employed in the insurance business.

Bill Beaton was active on the Sudbury political scene. In 1936, he was an Alderman for city council, a position that he held until 1940. By 1941, he was elected to the office of Mayor, and he held the seat for eleven consecutive years. In 1955 and 1956, he was elected to the Board of Control. He was also Deputy Mayor in 1956. Beaton ran for the provincial legislature, but lost his bid to Bob Carlin in 1943 and to Welland S. Gemmell in 1948. His accomplishments as Mayor include the replacement of the Sudbury-Copper Cliff Suburban Electric Railway Company with City Bus Lines, and the construction of the Sudbury Arena.

Beaton an influential figure in sports in Northeastern Ontario was active in swimming and canoeing, and he coached or managed hockey and baseball teams. Beaton was instrumental in organizing: the Northern Ontario Hockey Association (NOHA) in 1919, the Sudbury Canoe Club, the Nipissing-Parry Sound Baseball League, and the Sudbury City Hockey League. He won the senior tandem paddling race with G.G. McCubbin at the Canadian National Exhibition in 1926. They defeated Olympic paddlers, and set a new record for the course. Beaton and his wife Isla won nine consecutive mixed tandem canoe races in Northern Ontario. They competed until 1936. The Beaton Classic, an annual sports marathon in the city, is named in his honour. Bill Beaton passed away on April 1, 1956.

Scope and content: The Bill Beaton fonds consists mostly of correspondence, reports/personnel files, speeches and documentation. They pertain to the mayoralty during the economic boom years (1939-1958) for the city of Sudbury. The speeches were given at local events and at CKSO radio on a weekly basis. The records provide insight to the structure of the education system and the infrastructure of the developing city. Within the documents of the fonds, there are 3 scrapbooks of newspaper clippings. This fonds also contains documentation on the community of Sudbury that includes: service clubs, education, Inco and the hiring of employees, W. E. Mason, and the city championships. The correspondence and the documentation files also reveal the political views of Bill Beaton on national and international issues. Specific topics regarding the

debate over the Canadian flag and World War II are well documented.
