

**P066 Sudbury and District Ministerial Association fonds

Administrative history: The Sudbury and District Ministerial Association (SDMA) is a self-governing, interdenominational group that consists of ministers, parish workers, deaconesses and missionaries who promote Christian fellowship, ecumenism and charitable work through involvement in various community activities in the city of Sudbury. The constitution that was adopted on October 2, 1950, states that the executive consists of a President, Vice-President and Secretary/Treasurer. The remaining members of the SDMA work within various committees that address specific areas of concern for the Association. These committees are: Radio and Television, Crusade, Health Welfare and Hospital, Community Outreach and Fellowship. The constitution also states that the territory for SDMA includes the city of Sudbury and the surrounding district. A prerequisite for membership stipulates that members must belong to denominations that are also members, or associate members of The Canadian Council of Churches (CCC). The denominations that are considered for membership include: Anglican, United, Baptist, Presbyterian, Pentecostal, Assembly of God, Christian and Missionary Alliance, Salvation Army, Mennonite, and Ukrainian-Greek Orthodox. The YMCA is considered to be a member because of affiliated membership with CCC, and the Lutheran denomination is considered to be a member because of friendly association with CCC. An exception to the ruling regarding membership with CCC was allowed on October 8, 1963, when the Seventh Day Adventists were granted membership to SDMA. By 1964, the Serbian Orthodox denomination was also included on the mailing list.

Custodial history: The documents of the Sudbury and District Ministerial Association were found in the fonds of the Sudbury and District Historical Society that was received in April 1999. There is no documentation on the acquisition of the records by the Sudbury and District Historical Society.

Scope and content: This fonds attests to the activities and involvement of the Sudbury and District Ministerial Association in the Community. The fonds contains their Constitution, minutes and related papers, general correspondence, cash books, reports, pamphlets and mailing lists. The records are directly related to the organization of SDMA. More specifically, this fonds documents the social and educational involvement of an organization of Protestant churches in the Sudbury region. The cooperation of SDMA with several community-based organizations, as well as the participation of SDMA with regard to inter-church activities, is well documented. SDMA was involved in activities in the community such as: radio and television broadcasts of Sunday services, a nursing school at Memorial

Hospital, help for addiction and alcoholism, an emergency counselling service, religious education, a Northern Ontario home for unwed mothers, helping the families of strikers, weekly services at Pioneer Manor and the Sudbury Sanatorium, and submitting a report to the Royal Commission on Bilingualism and Biculturalism.

There are no documents for the year 1960, and very few documents for the years 1955 and 1959.
