Biographical sketch: Archibald “Archie” McArthur was a miner at Falconbridge Nickel Mines and union activist. In 1944, he served on the first bargaining committee of the International Union of Mine, Mill, and Smelter Workers Local 598 (IUMMSW) which negotiated with the company.

Robin Wayne McArthur (1942 -) was born to Archibald McArthur and Ruby McArthur (née Coxworth) in Sudbury, Ontario. He is the father of three sons: Brian, Derik, and Wayne.

In 1959, Robin became employed in Neelon and Garson Townships as a road worker and became a member of Mine Mill Local 902, participating in a strike. Subsequently, McArthur would play an important role in the labour movement in Northern Ontario serving in a variety of roles in the IUMMSW, the Retail, Wholesale, and Department Stores Union (RWDSU), Union of Food and Commercial Workers (UFCW), and Warehousemen, Transportation, and General Workers Union (WTGWU).

In 1960 he secured a job at Falconbridge Nickel Mines and joined Mine Mill Local 598. In Mine Mill, McArthur was elected and served as a captain from 1961-1962, Recording Secretary in 1961 and again from 1963-1965, and Business Agent from 1963-1966. In 1966, he was elected President and served until 1967. That year (1967) McArthur oversaw the merger between the IUMMSW and the United Steelworkers of America (USWA). The same year (1967), he joined the Northern Joint Council of RWDSU where he was elected Recording Secretary and Business Agent. He served as International Vice President of the RWDSU from 1982-2005, Director (the title later changed to President) of the Northern Joint Council from 1990-2005, and Canadian Director of RWDSU in 1994. In 1994 McArthur was also elected Vice President of the UFCW. McArthur, a founding organizer of Local 715 of the WTGWU, served as its President until his retirement in 2005.

Scope and Content: The Archibald and Robin McArthur fonds attests to the roles played by the McArthurs in mining and the labour movement in Northern Ontario. The fonds consists of correspondence, minutes, and other print materials from Mine Mill Local 598 and other unions. They also contain memorabilia, books, pamphlets, newspapers, articles and clippings, and photographs accumulated by both McArthurs.

More specifically, the Archibald McArthur series provides insight into his role in the Mine Mill Local 598 and its early period of organization, with a focus on early collective agreements between Mine Mill and Falconbridge.

The Robin McArthur series contains specific documentation about elections in Mine Mill Local 598 and McArthur's participation in these elections. The fonds also provide insight into the Mine Mill-Steelworkers dispute and eventual merger, which are significant events in Sudbury's and Ontario's labour history. Finally, his fonds provide information regarding McArthur's involvement in other unions including the RWDSU.

This series attests to Robin McArthur's involvement, activities, and achievements in the labour movement in Northern Ontario. Focusing on his activities in Mine Mill Local 598 it serves to inform us of the Mine Mill-Steelworkers dispute and subsequent merger. The series contains minutes, news clippings, correspondence, photographs, and print material relating to Mine Mill. The series also contains material relevant to the growth of the Northern Joint Council of RWDSU and Robin McArthur's subsequent career in organized labour.
